### BAC RESOLUTION DECLARING FAILURE OF BIDDING

WHEREAS, on November 23, 2021, Invitation to Bid with Reference No. 8211020 was posted in the Philippine Government Electronic Procurement System (PHILGEPS) for Procurement of Tour Service Operator for the Travel / Logistic Requirements of Clark – Busuanga – Clark Travel Bubble Outbound Tourism Exchange with a total Approved Budget for the Contract (ABC) amounting to One Million One Hundred Thirty-Nine Thousand Eight Hundred Philippine Pesos (Php 1,139,800.00). The said Invitation to Bid was also posted on the DOT-Region III Official Website and at a conspicuous place within the premises of DOT-Region III;

WHEREAS, on November 26, 2021, a virtual **Pre-Bid Conference** was held;

WHEREAS, as of 10:00 a.m. of December 9, 2021, posted deadline for submission of bids, one (1) bidder, **Global Access Travel and Tours**, has submitted their bid;

WHEREAS, on December 9, 2021 at 11:05 a.m., BAC Meeting was held for the **Opening of Bids**;

WHEREAS, upon opening the bids, the sole bidder, **Global Access Travel and Tours**, was disqualified due to the following reason:

Bidder	Issue/s
<b>Global Access Travel and Tours</b>	Non-submission of Tax Clearance per E.O. 398, s. 2005, as finally reviewed and approved by the Bureau of Internal Revenue (BIR)

WHEREAS, Section 35.1 (c) of the 2016 Revised IRR of RA 9184 provides that “The BAC shall declare the bidding a failure when all bids fail to comply with all the bid requirements...”

WHEREAS, in a meeting of the BAC on December 9, 2021, the BAC resolved to declare a failure of bidding in view of the aforementioned provision under RA 9184 and the end user was instructed to conduct a mandatory review and evaluation of the terms, conditions, and specifications in the bidding documents pursuant to Section 35.2 of the Revised IRR of RA9184.

**NOW, THEREFORE, FOR AND IN CONSIDERATION OF THE FOREGOING**, the members of the Bids and Awards Committee hereby resolve to declare a failure of bidding for the **Procurement of Tour Service Operator for the Travel / Logistic Requirements of Clark – Busuanga – Clark Travel Bubble Outbound Tourism Exchange**.


